As you are aware, School Education Statistics presently being collected through Unified District Information System for Education (UDISE), previously DISE and SEMIS (School Education Management Information System) separately, for both Elementary, Secondary and Higher Secondary Sector in respect of all schools including State Government Schools, Local Body Schools, Private Schools, Central Sector Schools, Ministry of Defense Schools, Ministry of Railway Schools, Ministry of Tribal Schools, Ministry of Social Justice and Empowerment Schools, Public Sector Undertaking (PSU) Schools, School attached to Institutes of Higher Learning, etc., in other words all schools in the country.

- 2. In our review meetings, information has been received that some States are having difficulty in getting UDISE data from organizations such as the KVS, NVS and other central sector schools of schools run by Government of India Ministries.
- 3. You will agree that in the absence of a singular authenticated schools data, it is difficult to estimate or plan activities and interventions needed for capacity building and to ensure quality education in schools.
- 4. I therefore request you to give instructions to schools managed by your organizations to fully cooperate with the UDISE exercise to be undertaken every year through the DISE team of the Schools Education Departments of the States and Union Territories.
