2. As per the revised timelines for the SVP 2017-18 process, the following is the schedule for the stages:

I. Selection for awards at the District Level and submission of the results to the States/UT level	1 <sup>st</sup> November, 2017 – 31 <sup>st</sup> December, 2017
II. Selection for awards at the State/UT Level	1 <sup>st</sup> January, 2018 – 31 <sup>st</sup> January, 2018
III. Submission of State/UT Level results to MHRD for National Level selection	•
IV. Selection of school for National Awards	30 <sup>th</sup> April, 2018.

- 3. All States and UTs are requested to expedite completion of the process by the above time lines.
- 4. The progress of the process has been reviewed. It is observed that as on date some schools out of the total of 4,22,119 eligible schools are still to compete the process for the District Level awards (evaluation survey and submission). It is therefore decided to continue the process of the Selection for awards at the District Level and submission of the results to the State/UT level till 15<sup>th</sup> January, 2018, concurrently with the next stage of Selection for awards at the State/UT level. There is no further revision in the timelines and it is requested that the process II above be completed by 31.1.2018.
