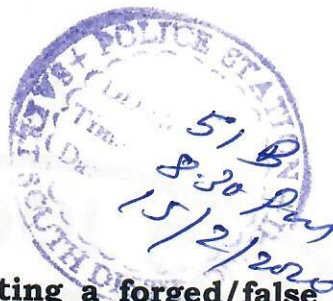

Respected Sir,

1. We are a registered society under the Societies Registration Act, 1860, since 1967, an autonomous educational body conducting public examinations for classes 10th and 12th for students of its affiliated schools across India.
2. This is to bring to your immediate attention that a forged and false document titled "IMPORTANT NOTICE FOR STUDENTS APPEARING FOR THE ISC EXAMINATIONS 2020" is being circulated on WhatsApp and email for the past two days. This forged document maliciously intends to mislead and misinform students currently appearing for the class 12 ISC Examinations. A copy of the forged and false document is annexed hereto and marked as **Annexure -1**
3. The ISC Examinations had commenced on the 3rd February 2020. The English paper -1 was scheduled for 14th of February 2020. It is believed that this forged and false document was created and circulated across the country to falsely mislead students with respect to changes in the question paper format of English Paper-1.
4. The document has been copied/printed falsely on the official letter head of our organization and my signature as well as name, designation has been forged/falsely copied.

These actions tantamount to various cognizable sections of the Indian Penal Code, 1860 such as Section 419 (cheating by impersonation), 468 (forgery for the purpose of cheating), 469 (forgery for purpose of harming reputation), 471 (using as genuine a forged electronic record), as well as Section 66-C and 66-D of the Information Technology Act, 2000 (Identity theft and cheating by impersonating using computer resource) are attracted.
6. You are requested to take immediate cognizance of these offences, initiate an enquiry, register a FIR and bring the guilty to book at the earliest.
7. We would be ever grateful to you for the same since the reputation of the organization has been harmed.
