**Subject: Cancellation of affiliation of Dasmesh International School,
Moga (PU148)**

Dear Principal,

It has been brought to the notice of the CISCE by the Department of Education, Government of Punjab vide letter dated 22.11.2023 that your school has been running illegally without having obtained the mandatory No Objection Certificate (NOC) from the State Government submitted by the school for the purpose of Provisional Affiliation from the CISCE.

CISCE vide its letters dated 01.12.2023 and 03.01.2024 asked the school to submit its statements/clarifications to the CISCE in the given time. In the event, the school fails to respond to the CISCE's letters. Considering the averments made by the Government of Punjab in their letter, that the school has not obtained the mandatory NOC from the State Government and the school is running illegally, it has been concluded that the offence of cheating and forgery has been committed by the school by submitting forged and fabricated NOC to obtain Provisional Affiliation from CISCE. The said offence is committed by the school with a sole malafide intention to run the school illegally.

On the basis of the aforementioned grounds the CISCE has decided to cancel the affiliation of your school with immediate effect.

Consequently, 10 confirmed candidates that will appear for ICSE 2024 Examination, will be admitted to another nearby CISCE affiliated school and their board examination will be conducted as per the CISCE's direction. Also, 32 registered candidates for ICSE 2025 Examination, may immediately be directed to take admission in nearby CISCE affiliated schools, transfer process of these candidates will be considered by CISCE.

You are also directed, to convey the cancellation of affiliation of your school to all the stakeholders such as students, parents and teachers without any delay. The cancellation of affiliation must be displayed on the Notice Board of your school. You are supposed NOT to take further admissions to class IX and X from now onwards.

The CISCE has register a complaint against the school in the Police Station Saket, New Delhi for further investigation in the matter.
